## **ETHICAL STANDARDS**

### **Ethical Standards**

All research conducted at the Divya Jyoti Ayurvedic Medical College is predicated upon a strict adherence to established ethical principles and standards. The safeguarding of the rights, welfare, and confidentiality of all human and animal subjects is considered a non-negotiable prerequisite for any investigation. To this end, an Institutional Ethics Committee (IEC) is formally constituted to provide oversight and approval for all research protocols.

The ethical framework is centered on several key tenets. Informed consent is a mandatory requirement for all participants in human subject research; the process must be conducted in a manner that is both transparent and comprehensible. The confidentiality and anonymity of all participant data are to be maintained with the utmost rigor. Furthermore, the integrity of the research process must be upheld at all times, with strict prohibitions against data fabrication, falsification, and plagiarism.

Any deviation from these ethical standards is subject to a formal review and may result in disciplinary action. The college is steadfast in its commitment to fostering an environment where scholarship is conducted with the highest degree of integrity and moral rectitude.

### **Detailed Ethical Principles**

The Institutional Ethics Committee (IEC) is a body formally constituted to evaluate all research proposals and to ensure their strict compliance with ethical norms. No research involving human or animal subjects may commence without the express written approval of the IEC. The committee's review is predicated upon the principles of beneficence, non-maleficence, and justice, thereby guaranteeing that the research benefits society without causing undue harm to individuals.

The principle of informed consent is considered an absolute requirement for all human subject research. This process entails a detailed explanation of the research objectives, procedures, potential risks, and benefits in a language and format that is readily understandable to the prospective participant. A written consent form must be signed by the participant, attesting to their voluntary agreement to take part in the study after having been fully apprised of its nature.

Confidentiality is an ethical obligation that extends to all aspects of data handling and storage. All data collected from participants must be anonymized or de-identified to the greatest extent possible. Secure methods of data storage are to be employed, thereby preventing unauthorized access or data breaches.

The integrity of the research process is paramount. Researchers are prohibited from engaging in any form of scientific misconduct, which includes, but is not limited to, the fabrication of data, the falsification of results, or the presentation of another's work as one's own without proper attribution. All sources of information and prior research must be meticulously cited. Violations of these ethical standards are subject to investigation by a disciplinary committee, and may result in sanctions ranging from the suspension of research privileges to academic dismissal, depending on the severity of the infraction.
